For those reporting on a fiscal year basis, the fee is due on or before the first month of the accounting year. A penalty of 5% per month or portion of a month and interest of 1% per month or portion of a month will be assessed on any late payments. In the event that a licensee engages in more than one type of activity in one business entity, the highest **MINIMUM LICENSE FEE** shall apply.
